Instructions for Admission to B. Tech 2009

1. Offered admissions must be confirmed by paying the fees (first installment), by Saturday, **11th July 2009, 5:00 p.m.**
2. Payment of fees should be made only through crossed demand draft (DD) in the favors of 'Symbiosis Institute of Technology' payable at Pune. In any case no cash payment is accepted.
3. Candidate can pay their first year fees in two installments.

a) First Installment –

4. Students must submit:
 - a. Two Stamp sized colour photographs
 - b. Original Copy of SSC, HSC Mark sheet and Certificate.
 - c. JEE/JEE-EML/AIEEE/MHCET/SET Score Card
 - d. Two duly attested copy of 10th and 12th Standard mark sheets and Certificates.
 - e. Transfer Certificate/Leaving certificate.
 - f. Original Migration Certificate
 - g. Cast Certificate
 - h. Certificate for (Differentially Able) Physically Challenged
5. For the reserved candidates
 - a. SC/ST: Two attested copies of the Caste Certificate along with the validity certificate from the respective competent authority of the State or Central Government
 - b. Differently able: Two attested copies of Medical Certificate
 - c. Kashmiri Migrant: Two attested copies from the respective competent authority of the State or Central Government
 - d. If candidate is not attending counseling, he / she can send the Authorized Representative for counseling by duly filled Authorization form, which is provided on website
6. SIT reserves the right to cancel the admission of the students in case of any of the certificates do not validate the information given in the application form
7. All admissions are Provisional and are subject to candidate's fulfilling of the eligibility criteria published in the SIT prospectus as per Symbiosis International University.
